Please include two (2) letters of recommendation. One should be from a school official, teacher, or professor. The second letter can be from any other person in your community who knows you. Please note that all recommendation letters must be placed in a sealed envelope by the writer of the letter or emailed directly to shelley.tuteur72996@gmail.com.

FINANCIAL INFORMATION

Please attach your 2018 Federal Income Tax Return (specifically pages 1 and 2 of form 1040) and those of your parent(s) or legal guardian.
